SUBJECT : PSETA QUALIFICATIONS STATUS UPDATE

DEAR PSETA STAKEHOLDER

- The qualifications registered on the Occupational Qualifications Sub-Framework (OQSF) have a lifespan determined during the registration process. All Historically Registered Qualifications (HRQs) that met a certain criterion as determined by the South African Qualifications Authority (SAQA) in consultation with the Quality Councils were re-registered until 30 June 2023.
- PSETA previously communicated to all accredited Skills Development Providers through Circular ETQA -02/2021 that SAQA had decided to de-register the following two qualifications with effect from 30 July 2020.
 - a. SAQA ID: 67460: National Diploma in Public Administration, NQF Level 6, credits 240; and
 - b. SAQA ID: 57827: National Diploma: Public Administration, NQF Level 7, credits 260.
- 3. On 14 July 2021, the SAQA National Qualification Framework Qualifications Committee considered the QCTO request to re-register or de-register certain qualifications. The Committee has *approved the re-registration* of the above-mentioned qualifications aligned to the timelines provided in the new Ministerial Determination of the Sub-frameworks that comprise the NQF (Notice 1391 dated 24 December 2020) as follows:
 - a. The new registration end-date is 30 June 2023;
 - **b.** The last date of enrolment of first-time learners is 30 June 2024; and
 - c. The last date of achievement for enrolled learners is 30 June 2027.
- 4. Thus, the two qualifications will continue to be available in line with the new registration end-date.
