

ADVANCED DIGITAL ENTREPRENEURSHIP PROGRAMME FOR 50 SMALL, MEDIUM AND MICRO ENTERPRISES (SMMES) FOR THE 2022-23 FINANCIAL YEAR

The Public Service Sector Education and Training Authority (PSETA) invites PSETA accredited Skills Development Provider(s) (SDPs) to apply to participate in the Advanced Digital Entrepreneurship programme, which will be delivered by the National Electronic Media Institute of South Africa (NEMISA).

1. PROGRAMME DETAILS

- The identified programme aims to develop knowledge of digital skills for exploring, starting, running, and growing a digital enterprise.
- b. The programme is for a duration of 15 DAYS ((5 Days -Contact Sessions; 8 Days of Selfstudy, research, and portfolio evidence gathering; 2 Days Portfolio Packaging and submission) with facilitator.
- A hybrid of virtual and face-to-face training methods will be used.

 - ii. Being an Entrepreneur
 - iii. Identifying Market Opportunities and Innovations
 - iv. Business Planning (Business Model Canvas)
 - v. Running and Managing a Small Business (E-Business/Digital Enterprise)

- a. Must be accredited as a Skills Development Provider (SDP) with PSETA
- b. Must be an SMME (Director/Staff member or Affiliate)
- c. Grade 9 (Standard 7)
- d. Digitally literate
- e. Maximum number of attendees Two (2) members per SMME
- f. Proof of relationship (letter) Attendee/s representing the SMME
- g. Certified copy of your Identity Document
- h. Companies and Intellectual Property Commission (CIPC) certificate/document indicating the SMME registration
- i. Completed and signed PSETA Skills Programme form
